### **Supervision over Construction of Water Treatment and Biogas Power Generation from Acelhuate river Water Project.**

**Project: Water Treatment and Biogas Power Generation from Acelhuate river Water**

**Project, Financing No.: 1/835**

**Sector: Energy. Water Treatment.**

**Project Description:** The project consists of the construction of a wastewater treatment plant that will purify approximately 70% of the wastewater from the San Salvador Metropolitan Area (AMSS). Additionally, it will generate renewable electrical energy through a small hydroelectric power plant (PCH, known as Pequeña Central Hidroeléctrica in Spanish), operated by the effluent flow of the Wastewater Treatment Plant (WWTP known as EDAR in Spanish), a photovoltaic system (PV), and two thermoelectric units that will run on the Biogas generated in the water treatment process.

The Government of Republic of El Salvador has received financing from the Saudi Fund for Development (SFD) toward the cost of Selection of consultancy services of Supervision of construction of Water Treatment and Biogas Power Generation Plant - Acelhuate River, and it intends to apply part of the proceeds toward payments under the contract for consultancy services for the supervision of the project. The objective of the assignment is to carry out, supervision and monitoring of physical progress, quality and the financial status of the construction works with the objective to ensure that the works are completed on time, meet the engineering specifications, social, and environmental standards, including pre-construction phase related to selecting the construction contractor.

The services are expected to cover forty-four (44) months period from the commencement date. It comprises of,

Phase 1: Pre-construction – twelve months (12)

Phase 2: Construction – thirty two months (32)

invites eligible consultants to indicate their interest in providing the required services. Interested consultant should provide information demonstrating that they are fully qualified; have required qualifications and relevant experience to perform the consulting services. The selection criteria of the consultants will be based on the following:

- Organizational structure showing key departments to perform the required supervision.
- The candidate to have at least five permanent staff working for the candidate in fields related to the contract Supervision of Works.
- Years of operation of the firm greater than or equal to 10 years.
- Accumulated amount greater than or equal to US\$5 million, of contracts for consulting services for the design or supervision of civil works, in the last 5 years.
- The candidate has provided services in at least three contracts/projects in construction supervision services with a budget at least USD 2,000,000.00 each, in the last 15 years.

Consultants may associate with other firms to form a joint venture or sub consultancy to enhance their qualifications. The Proposal must clearly indicate the type of intended association as joint venture or sub consultancy and the lead firm in the Expression of Interest.

A consultant will be selected in accordance with the Quality and Cost Based Selection with the procedures set out in the Guidelines for the Use of Consultants under Saudi Fund for Development Financing. Consultants may express interests in the forms of association, validated by an agreement among members of the association which clearly specifies the type of association, i.e. a joint-venture, intermediate forms of association, or sub consultancy. The Call is open to Saudi Arabian companies and Joint Venture between Saudi Arabian and Salvadorian companies.
